- Contract to be awarded in accordance with Parish Council financial regs. JCT minor works contract considered to be appropriate

- Work delayed until 26/27. Funds need to be budgeted accordingly. An updated budget figure will be required for November to allow preparation of the full Parish Council budget, for agreement at the January PC meeting
